Chairperson South Dakota RSC Chairperson Report June 02, 2023

Dear South Dakota RSC Members:

This report is being written one day after the June 2024 RSC meeting so it will contain some information not available at yesterday's RSC meeting. I would like to first thank the RSC for the trust and opportunity to be of service to our region in this new position. There are a few items to report, including the following:

- All signature updates have been been completed today with the RSC checking account. The Treasurer and I have both signed the updated back signature card, so this document reflects the current proper officers. This matter was pending as of the RSC meeting. The bank made a necessary correction and all matters have been resolved as of June 3, 2024.
- I received approval at the RSC meeting for the \$9.90 overrun for the cost of purchasing an annual Zoom account (\$159.90 total). I am ready to submit this subscription, but would like to tie it to the RSC Chairperson e-mail address rather then a personal e-mail address. This will help ensure that the Zoom account remains accessible to the RSC after any future change in officers. I have reached out to the web servant to take the necessary steps to access the RSC chairperson e-mail address. I will submit the Zoom subscription order once I can log into the RSC Chairperson e-mail account. I expect this matter to be completed within the coming week. The RSC has approved reimbursement of this expense. I will submit receipts for the subscription to the treasurer once the this transaction is complete.

- It was determined by the RSC that the PO Box key will remain in the possession of Carol P for the time being. This was brought up as a question as the topic is not addressed in current policy. Carol will retain the key and continue to check the PO Box for this coming year.
- The June RSC open forum included discussion on the theft of group funds from a meeting. I talked to the West River Chairperson and gave him my contact information in case any assistance or input is requested on the matter.
- I would like the thank both ASCs for their time in reviewing the RSC policy guidelines. After much work over the last couple years, we have newly approved RSC policy guidelines.

I believe that is everything I have to report at this time. The next RSC will be help on Sunday, September 8 at 1 PM Central / noon Mountain via Zoom. Meeting details will be posted on the regional web site (<u>https://sdrna.org</u>) in the weeks preceding the meeting.

Open Forum

- 1. Person searching for meetings used <u>www.narcotics.com-meetings/south-dakota/rapid-city/</u> to get meeting information from google search. This is not associated with NA, and has the wrong information. Hailey and Alex are looking into the situation.
- 2. Loss of funds was discussed. One needs to look into accountability, how funds are secured, and how to handle funds responsibly. Region has offered help, but we must keep in mind autonomy of the group.
- 3. Communication: this is an ongoing area of improvement for SD Region. The little scattered meetings are not getting the information from areas or from region. We have taken strides forward by having the website rebuilt and by organizing the helpline for the region. Now we are going to reach out via snail mail and send convention information. The secretary will also send minutes to all available email accounts associated with the region that are known at this time. Ask home groups of ways to bring the outlying meetings into an area or help form an area. Not all services need to be provided for an area to form. If you know people from other towns that do not participate in an area, ask them to come to region meetings via zoom. Let's try to open the lines of communication.

Old Business:

- 1. Regional Policy Review -unanimous approval. Carol will clean up the final copy and send to be posted on the website, and to each RCM.
- 2. Elections open positions:
 - a. Vice Chair no nominations
 - b. Region Delegate no nominations
 - c. Region Delegate Alternate Bonnie D. Sioux Falls
 - d. Web Servant Alex C Sturgis
 - After area reviews these candidates will be up for election in September.
- 3. Regional Zoom Account moved to new business

New Business:

1. Zoom Account: The amount increased to \$159.90. Approved to spend the extra amount of \$9.90. Drew B. will pay via credit card and provide receipts to be reimbursed by check.

2. Key to PO Box: it is not addressed in policy as to who should have the responsibility of holding the PO Box key and checking the mailbox. Carol has been doing it since it moved to Rapid City. It was agreed that she can remain doing so, but we need to look into adding that to policy after deciding how that can be completed due to location of box and possible position holders. Should it be the treasurer, secretary or chairperson/or vice chairperson? Or we can look at having a trusted servant from Rapid City be the "Holder of the Key".

3, Review of facebook page: conversation included a variety of viewpoints: younger people are cedentered on getting information via their phones, therefore the facebook page could be a benefit; the facebook page cound be used as a placeholder page to direct traffic to our website; webpage could provide more immediate response than helpline, or visiting website. More people are needed to have a committee, so not all of the work falls on one person.

It was decided to keep it as is until we get more people involved in region service.

4. Fund flow- SD Region has in excess of \$4000 over budget. It was unanimously approved to forward \$1000 to NAWS.
