#### Chair

### **Webservant Facilitator**

Hello my name is Alex, and i am a addict.

I have a few things to report on today starting off with the facebook page. The Facebook page has be going well. In the last 90 days (March 9- June 5) we have seen 3,476 views a increase of 1759%. 171 interactions a increase of 4175%, and 22 new followers a increase of 633%. The post with the convention flyer had the highest number of people reached @ 273.

I was in contact with Heartland Solutions about the "For Professionals" tab not working on the web page but has been updated and is now working. I also had asked about adding a donation page to the website. Something like the <a href="mailto:namontana.org">namontana.org</a> page has. This is the response i did receive from Trisha.

### Good Morning Alex!

I've done many donation pages exactly like the one you linked too. We already have the form capability, we just have to add a Square account. There is no cost to the organization from my side of things to add this capability.

For the organization, you guys have to open a Square Account and add your organizations bank account. Once you have a Square account setup and tied to the bank account, I ask that you send me the login information, and if you have 2 factor auth setup in the square account to add my cell number as one of the numbers that can get the code sent too. That allows me to log in and out of the square account while I do testing of the form, and to "link" it to the website. The website "logs in" to square and gets permission to process the payments, then the website stores the authorization to work automatically. Just to reassure anyone that asks, I can't access your bank account directly with it being linked in square, and I don't store the login information anywhere once it is linked to the website. And if the person can't get my cell number added to two factor auth, I'll do it when I get login info.

Square is pretty easy to setup, just go to Squareup.com and sign up. If at any point it asks you to pay for a service, upgrade to a pay service or setup some sort of website, decline. The part of square you want is free except for the credit card processing fees, which it will tell you what they are once you are in. Most are 2.9% + .35 transaction fee, averaging 3.5% per transaction.

Once you have a Square account setup and send me the login info, I will setup the donation form on the site and test it. I do ask that the organization require a

minimum donation of \$10-\$25, what that does is discourage credit card scammers from using your form as a testing site for their fraudulent credit cards. I had an organization that didn't put a minimum on and Square will lock the account if it looks fraudulant by running \$1 transactions. So to implement some security I have Google Auth and a minimum setup on the form.

FYI - Once all setup when a person donates, the website sends the person a receipt, the webmaster/or treasurer gets a notice that a donation goes through, and if you have square setup right, it will just move the money to your account overnight. Works pretty slick!
