RD RD Report March 2, 2025

The Interim conference just finished! You will be the first region to get all of the results!

On Friday we voted on 8 of the 12 motions, and ran out of time. There were some technical difficulties to overcome first, and then we went quickly.

Motion 1: to adopt for the 214 interim WSC and the 226 WSC only: if a motion has consensus in an initial straw poll (that is 80% or more in support or not in support), the Cofacilitators will announce the results as a final decision:

Final vote: 84 yes; 35 No; 2 abstain; 3 present not voting = 69% strong support Motion approved

There were some amendments to the motion which all failed:

A1: to include 2 voices of dissenting voices

A2: to add: of all conference participants with rights to vote on that motion or amendment:

A3:to increase % to 95%

A4; to increase % to 90%

A5: to increase % to 85%

Motion 2: to approve the 2023 WSC minutes

Final vote: 114 yes – 1 No- 1 Abstain- 1 Present not voting 98% Consensus Motion approved

Motion 3: To approve 2025-2026 NS World Services Inc. budget:

Initial straw poll: 119 Y, -1N; 4 Abstain- 2 Present not voting 95% consensus- final decision due to #1 passing

Motion 4: to extend the 2023-2025 reimbursement policy

Initial Straw Poll 118 Y-2 N-4A-2 P 95% consensus motion carries

Motion 5: The 2026 WSC will take a new step in WSC 2026 planning to utilize member input to prepare the Discussion/literature survey.

Initial Straw Poll: 112Y- 6 N- 6A- 2 P 90% consensus, motion passes

Motion 6: Amended: To update a Guide to World Services in NA amendment deadline policy to include first draft due 60 days in advance of WSC and final amendment 45 days in advance of WSC.

Final vote 111 Y- 8 N- 0 A- 1 P = 93% consensus, motion carries

Motion 7: Amended: to add to SWSNA amendment deadline policy to include first draft due 45 days in advance of any interim WSC and final amendment deadline 30 days in advance of interim WSC.

Final vote: 106 Y- 8 N- 2 A-2 P = 91% consensus Motion carries

Motion 8: an amendment to a motion is a change or addition deigned to improve the motion.

First straw poll: y-119; n-1; a-4; p-2 = 95% consensus,, motion carries

Motion 9: The conference may decide to replace or amend motions that have been presented based on prior discussions. When the motion is present4ed, the WSC Cofacilitator may offer a replacement or amendment during the discussion of a motion. If supported by 2/3 of the conference, the replacement/amendment will be accepted.

Initial straw poll: 103-Y; 11-N; 9-A; 3-P = 83% consensus support, motion carries.

Motion 10: All candidates for World Service positions are forwarded to the HRP from Regions, Zones, or WB- RBZ

Initial straw poll: 113 -Y; 5-N; 5-A; 3-P = 91% strong consensus, motion carries

Motion 11: If motion carries, to redefine ethe purpose of the World Pool to be used to retain information on candidates forwarded for consideration by regions, zones and the WB as part tof the HUMAN Resource Panel's process.

Initial straw poll 111Y; 6N; 7A; 2P= 89 % consensus, motion carries

Motion 12: to not utilize a seating workgroup for the 2023-2026 cycle.

Initial straw poll: 105 y; 7N; 11A; 3P= 85% consensus- motion carries
