Chairperson report to SDRNA September 2025

Per conversation at several Region meetings and PSZF discussions over the past few years, I have explored the process of registering SDRNA as a business with nonprofit status. In order to protect individual responsibility for income and expenditure, it was recommended that nonprofit status would benefit the region. I contacted the Secretary of State of SD and requested information. Upon review of that information, the process is quite simple. I registered South Dakota Region of Narcotics Anonymous LLC as a limited liability corporation, hence, the LLC. I also filled out the items for incorporation for non-profit status. In those forms it is required to state the source of income: totally by member only donation as well as expenditures: process of carrying the message of NA recovery to fellow members, professionals who work with addicts, and people who may become members, such as those incarcerated or in other institutions. The articles of incorporation have been filed and are awaiting approval. As chairperson I have listed myself as the contact for this process.

By request from the Convention committee, I also registered for a SQUARE account and purchased the equipment needed to take payments by credit card at the convention. The convention will pay for the equipment. I have donated the first month's access for the convention. After receiving non-profit status, there will not be a fee for the processing. I will update the account at that time. This process can also be utilized on the webpage for donations after utilizing the web-page coordinator for the addition. This will be discussed in the meeting today.

We have had a few meetings close, but through our website and through the helpline, I have been made aware of new meetings being organized and opening. We must reach out as members to the new locations and help them become stronger and be able to reach more addicts seeking recovery.

I am proud to have been asked to be a speaker for SD Region in today's World Unity Day activities. Thank you for believing in me as I carry the message of recovery. I am truly humbled.

West River Area last met in July. It was a hybrid meeting of in person and zoom. Carol and I attended via zoom while on vacation in North Dakota. We suggested that the area purchase a microphone and a speaker for the hybrid meetings. They were both purchased for less than \$50. It should make hybrid meetings much easier to hear and contribute to when there is a group of people in one place joined by individuals outside of the room.

We do not have an H&I chair at this time, but the H&I commitments are being serviced on a regular basis. Carol and Becky are contacting local professionals for a PR presentation on the Friday before the convention in Spearfish.

The events that we have coming up include the Black Elk Peak hike on September 21st. Our chair is open for Unity events as well. The Sheridan Lake campout during the rally was a success. A donation of \$285 was raised for Project Primary Purpose by having a BBQ for \$10 a person.

Our budget for the year is \$4100. Our balance sheet shows that we still have \$2100 left of budgeted amount to spend, and our balance in the bank at this time is \$6362.85. We donate once a year to NAWS, SDRNA, and PSZF when our budget for the year is approved. All excess funds above the budget amount is dispersed to 1/3 each to each entity.

The region is asking for each area to ask a person to **co-facilitate the region's facebook** page, as well someone to **co-facilitate our webpage**, with the intention of becoming the next technology facilitator for the region when Alex's term expires.
