The WB is asking the Fellowship to extend current trusted servant terms who are to expire in 2022 for one year so that we may follow through with WSC 2022 business. Our Region guide lines say that an RD may only serve 2- 2year terms consecutively. I am willing to serve another year if the Region wishes.
